1. Language Requirements

1.1 Working language in Saskatchewan

English is the recognized working language for healthcare in Saskatchewan. New membership applicants are required to be fluent in English, pursuant to the SSMLT Regulatory bylaws. Research has confirmed that a high degree of proficiency in reading, writing, listening, and speaking is extremely important for providing safe Medical Laboratory services. 1,2

Applicants must meet the English language requirement to be eligible for registration. This policy outlines the SSMLT registration requirements.

2. Evidence of Language Proficiency

Any one of the following will be accepted as satisfactory evidence of English language proficiency:

- 2.1 Successful completion of a Canadian accredited medical laboratory technology/science program, which the language of instruction was English within the past two (2) years; or
- 2.2 Letter of Standing from a Canadian Medical Laboratory regulatory body that verifies at least 1200 hours of MLT practice hours within the past two (2) years where the practice setting was English; or
- 2.3 Achievement of the minimum scores outlined below in one of the approved language fluency tests:
